### DOG PARK RULES

HOURS OF OPERATION: DAWN – DUSK

ENTER DOG PARK AT YOUR OWN RISK.

NO SMOKING, ALCOHOL OR DRUGS

NO PROFANITY

NO SKATEBOARDS, SKATES, RAZORS, ROLLER BLADES, SCOOTERS , BICYCLES OR SIMILAR RECREATION EQUIPMENT

NO PETS (EXCEPT SERVICE ANIMALS)

ALL TRASH IN RECEPTACLES

DOGS MUST DISPLAY A VALID LICENSE AND CURRENT RABIES VACCINATION TAG.

DOGS MUST BE LEASHED WHEN ENTERING AND EXITING DOG PARK.

DOG OWNERS MUST CARRY A LEASH; HAVE DOG WITHIN SIGHT AND UNDER VOICE CONTROL. OWNERS MUST ACCOMPANY DOG INSIDE FENCED AREA.

OWNERS MUST CLEAN UP AFTER THEIR DOG AND DISPOSE OF PROPERLY.

ALL DOGS MUST BE UNDER THE CONTROL OF AN ADULT AND THERE IS A MAXIMUM LIMIT OF 2 DOGS PER ADULT.

NO CHILDREN UNDER 16 YEARS OLD ARE ALLOWED IN PARK UNLESS ACCOMPANIED BY AN ADULT. CHILDREN MUST BE CLOSELY SUPERVISED AT ALL TIMES.

DOG MUST BE REMOVED FROM THE DOG PARK AT THE FIRST SIGN OF AGGRESSION TOWARD A PERSON OR DOG.

NO GLASS CONTAINERS OR FOOD (PEOPLE/ANIMAL).

REMOVE CHOKE, PINCH (PRONG) SHOCK & SPIKE COLLARS FROM DOGS BEFORE ENTERING PARK.

IMMEDIATELY FILL IN ANY HOLES YOUR DOG DIGS.

PROHIBITED FROM THE PARK AT ALL TIMES: FEMALE DOGS IN HEAT, AGGRESSIVE DOGS, SICK DOGS, DOG UNDER 4 MONTHS OF AGE AND PETS OTHER THAN DOGS.

DOG TRAINING CLASSES ARE PROHIBITED.

DO NOT LEAVE DOG UNATTENDED.

KEEP GATES CLOSED AT ALL TIMES.
