

### Council Meeting Minutes 09 May 2017

President Joseph Sain called the April regular meeting of the Matamoras Borough Council to order at 1930 hrs. on Tuesday, 09 May 17 in the Borough Hall, 10 Avenue I, Matamoras, PA.

Present were Councilman Rose, Greiner, Madsen, Sigreto and Mayor Clark. Councilman Clark and Losee were excused. Also present were Secretary Fitch, Treasurer Myer, Tax Collector Drake, Jr. Councilwomen Strenk and Waszcyszak, Assistant Chief E. Stewart Solicitor Hamill. Waszcyszak, Fire Chief Long and EM Coordinator Olver was absent. There were approximately 15 residents in attendance.

Prior to Public Comment, President Sain went around the table and asked if any council members had items to add to the agenda. The following items were added to the agenda; hiring employees for the park; reimbursing the FD for their new insurance policy cost increase; formation of a real estate committee and purchasing a new vehicle for the DPW.

#### 6. New Business

- 1. President Sain thanked Tom Long for the new mulch in front of the Borough Building.
- 2. **Motion** by Rose/Greiner for adoption of Ordinance #329, to institute no parking the north side on Avenue S from 7th Street to the new school entrance and Seventh Street on the east side from 7:00 to 9:00 am and 2:00 to 4:00 pm 15 Aug to 15 Jun; passed without dissent.
- 3. **Motion** by Rose/Sigreto for adoption of Ordinance #330 to expand the Recreation Advisory Board to nine members. Passed without dissent
- 4. **Motion** by Madsen/Rose for adoption of Ordinance #331 to amend Chapter 124, Zoning to include regulation of Mini Cell Towers and Antennas, Distributed Antenna Systems and Data Collection as amended to correct references to Dickson City Borough. Passed without dissent.
- 5. President Sain began a discussion over the use of drones in the Borough and establishing guidelines and no fly zones. Following a brief discussion, the matter was referred to General Government for action.
- Motion by Greiner/Madsen to purchase a cyber insurance policy for approximately \$1650.00 a year. Passed without dissent.
- 7. **Motion** by Rose/Madsen to hire George McCormick and Jeff Lawler to work in the park. Passed without dissent.
- 8. **Motion** by Sigreto/Rose to approve covering the \$1500 increase in the MFD insurance for moving them from the Borough's policy to their own with VFIS. This is a one-time appropriation. Passed without dissent.
- 9. Motion by Rose/Madsen to form a real estate committee comprised of Madsen, Greiner and Hamill to research property for a new Borough Hall and Police Building and to authorize the Secretary upon direction from the committee to engage appraisers to secure fair market values on any properties. Passed without dissent.
- 10. **Motion** by Greiner/Madsen to purchase a new vehicle from Freightliner (COSTARS Contract) for the DPW at the cost of \$115,763.45 to replace the current International Truck. Greiner reported bids from Mac at \$141,750 and International at \$124,929 for the same vehicle specs. Passed without dissent
